2. The Meeting presided by Chairman Ch. Asif Ali, started at 03:00 PM with the recitation of the verses from the Holy Qur'aan by Hafiz Ghulam Yasin (Trust Seed Corp., Rahim Yar Khan), after which Secretary General SAP welcomed the participants and announced the agenda and order of proceedings of the meeting, followed by a request to the honorable Chairman to address to the House. Details of these proceedings including summary of Chairman's Address is as follows:

Ch. Asif Ali, began his speech with the recitation of the verses from the Holy Qur'aan and extended warm greetings to the office bearers and members of the Association. He thanked them all for their support, particularly his fellow office bearers, the members of the Executive Committee and support of the former Chairmen Mr. Salman Mahmood Khan and Ch. Bilal Ahmad.

He explained to members, that at the beginning of this tenure, a certain group that has been lobbying for some time wanted to create a monopoly and tried to influence the recently formed Punjab Agriculture Committee under instructions of the Governor Punjab through misleading information to seek transfer of seed enforcement powers to the provincial authorities. However, through the efforts of Seed Association of Pakistan, including the meetings with the Federal and Provincial Authorities, this attempt to destroy the seed sector was stopped.

He also informed that despite the Orders by the Honorable High Court Lahore, the officials of the Provincial Food Departments continued to impede upon the authority of the FSC&RD, which caused several delays, however SAP took lawful action under the Court Orders to restraint Food Department, which led to the Department officials to negotiate a process with SAP to ensure smooth procurement. The seed companies thus succeeded in record production and procurement of the certified wheat seed.

Chairman also highlighted that following a successful meeting with the SAPM Food Security, import issues were discussed with the Director Technical at Department of Plant Protection and VEC issues including DNA Fingerprinting were discussed with the PARC officials. The outcome of these meetings was positive and



these matters will soon be resolved. However, he stated that the companies need to reinvent and reinvest in their Research and Development to cope with future challenges in the seed industry.

He also welcomed the new members who joined the Association, and was pleased to share that all applications for membership received were approved by the EC during his tenure.

He concluded his speech by thanking his fellow office bearers, the members of the Central Executive Committee and all members of the Association who supported him during his tenure. He also appreciated the Secretary General and Secretariat staff for their efforts during his tenure and offered his best wishes to the incoming office bearers upon announcement of results by the Chief Election Commissioner.

- 3. Since the Senior Vice Chairman was unable to attend the meeting thus the Secretary General requested the Vice Chairman to deliver his farewell address. Mr. Muhammad Azam Cheema, Vice Chairman, commenced his speech with by expressing his gratitude to the Chairman, the Members of the Executive Committee and the Secretariat for their support and cooperation. He also welcomed the new incumbents of the EC as well as office bearers whose name will be announced by the Chairman Election Commission. He also suggested that the Association should also establish Crop Boards. He concluded his speech with the best wishes for the Association.
- Confirmation of minutes of last year AGM.
 Secretary General SAP presented the minutes of the previous year's AGM which were approved by the House through show of hand.
- Consideration and adoption of Annual Audit Report 2020-21.
 Secretary General then presented the Audit Report for review to the House. The report was approved by a show of hand after a thorough review and satisfactory answers to the questions raised by the participants.
- 7. Appointment of Auditor and Legal Advisor for SECP (2021-22). Secretary General informed the members "Yameen Riaz and Company" has submitted their proposal to continue offering their services as Auditors. The House agreed to the proposal and approved the appointment of auditor and their remuneration. Furthermore the House also approved to continue with Mr. Munawar Almas as the legal advisor for all SECP and tax filing matters on existing retainership fee.
- 8. Status of EC Funds / Donations for Legal expenses Secretary General furnished details of the status of EC Funds and the Donations for Legal expenses. It was once again stressed that members whose dues were still outstanding must deposit funds in SAP account at the earliest as funds are essential for smooth functioning of the Association.
- 9. Consideration and adoption of annual budget for 2021-22. Secretary General presented annual budget, given below, which was passed by the House by show of hand.

12. Address by Vice Chairman Elect

Mr. Saleem Bari thanked the members of the Association for voting for him and providing him the opportunity to serve the Association and assured members of his full commitment for betterment of SAP and his full support to the newly elected Chairman is resolution of industry matters.

- 12. Address by Senior Vice Chairman Elect Mr. Sher Ali also unable to attend the AGM due to some family concerns. He however conveyed his message of thanks to the members through the Secretary General.
- 13. Address by Chairman Elect

Chairman Elect Ch. Salman Mahmood Khan expressed his gratitude to the members of the Association for voting him in and bestowing him with their trust and belief, to once again represent the Association. He highlighted that some Government officials, such as the recent Additinoal Secretary, who are biased toward the industry due to possible vested interests deliberately present a negative image of the industry. The recent SROs formed under his guidance without any consultations with the stakeholders is a clear sign of efforts underway to undermine the seed industry. It is unfortunate to say that the officials of FSC&RD



supported him in this activity. Another such officials is the DG Agriculture Extension who is on the position for nearly 18 years, and has made numerous attempts to take control over the seed industry as well.

He informed participants that now he is also behind creating circumstances to encourage Sindh to enact a provincial law, so that Punjab may follow suit. However, SAP has recently held meeting with the Chairperson PPP Mr. Bilawal Bhutto Zardari, who has given explicit instructions to his party not to promulgate any act which damages the national seed industry.

He also informed the members that he will soon be holding another meeting with the SAPM Food Security Mr. Jamshed Iqbal Cheema and discuss with him the anti-industry Seed Rules and seek their reversal. He is very hopeful that Mr. Cheema will be cooperative and do the needful.

He once again thanked the members for their support and ensured them that he will continue to strive for the betterment of the industry.

- 14. QA Session / Following additional points / suggestions were raised with permission of chair:
 - a. Mr. Muhammad Azam Cheema suggested as was the practice in the previous years, to support the Association economically, members who are willing to donate to the Association, may announce donations to help in improve the finances. Chairman SAP endorsed his proposal and appreciated the gracious donations announced by several members.
 - b. Mr. Mehar Afzal and Mr. Asim Butt were of the opinion that the Association should take the matter related to the new Seed Rules to the Court of Law for relief.
 - c. Mr. Naveed Afzal congratulated the office bearers and raised his plea for a preemptive planning to resolve the possible hinderances in upcoming wheat seed movement.
 - d. Ch. Bilal Ahmad congratulated the newly Chairman, Senior Vice Chairman and Vice Chairman and especially thanked the members for the votes and support during the elections. He sided with the opinion that the serious concerns regarding the new Seed Rules should be first discussed with the SAPM Food Security for an amicable resolution, and the Court of Law should be the last resort. Similarly the matters with the Agriculture Department Punjab should also be resolved through discussions. He also assured that he give his full support to ensure the wheat seed movement in the upcoming season.
 - e. Ch. Asif Ali and Mr. Muhammad Athar Iqbal also congratulated the new office bearers and endorsed the proposal to first seek a resolution through meeting with the SAPM Food Security. Majority of the members were in agreement of this proposal.
 - f. Mr. Naseer Warriach, also congratulated the new Chairman and his team and requested to encourage SAP members to focus significantly on the heat tolerant varieties.

15. Awards and Certificates to retiring Central Executive Committee Members Following the tradition of the previous AGMs, to the avoid interruption in continuity of the AGM proceedings the awards ceremony was scheduled at the end. Since the EC members served under the Ex-Chairman Ch. Asif Ali, he was thus requested to present awards and certificates to the retiring EC members.

- 17. Awards and Certificates to the retiring Chairman Chairman Elect Mr. Salman Mahmood Khan, presented a bouquet along with certificate and award to Ch. Asif Ali, the retired Chairman.
- Certificates of Excellence to the SAP Secretariat Staff
 Mr. Salman Mahmood Khan also presented the Certificate of Excellence to the Secretary General and the Office Coordinator for their eminent service to the Association over the past year.
- 19. The meeting adjourned at 04.45 PM with vote of thanks by the Chair followed by a group photo session.
